# **Background**

In 2021, Ofcom unveiled the One Touch Switch (OTS) regulations, designed to streamline the transition for customers switching their fixed voice and broadband service providers. Under the OTS framework, comms providers (CPs) are required to participate in the OTS industry process by exchanging switching messages via the TOTSCo Industry Hub messaging platform.

This integration involves a sophisticated system of APIs and security protocols, ensuring seamless communication between providers and the Hub. It includes bidirectional data flow, with providers sending requests to the Hub and receiving service requests from it, all backed by stringent performance assurances.

The TOTSCo Hub will be live from 12th September 2024.

We used our advanced knowledge of the OTS process to develop SureSwitch, the only standalone, modular OTS solution for any CP, regardless of size or existing infrastructure.




# **Splynx Integration**

We have teamed up with Splynx to provide the simplest and fastest method for integration to the TOTSCo Industry Hub.



## Configuration

On the SureSwitch web portal, simply select Splynx as your Match Provider and Event Publisher and provide your Splynx credentials.





# **Splynx Integration**

## Splynx Match Provider

The Splynx match provider connects to your Splynx environment and matches against your active residential customers. Support is provided for Internet services, Voice services, and Bundles.


#### **Match Requests & Switching Implications**

SureSwitch receives match requests on your behalf, and performs customer matching against your Splynx environment. Match results are provided automatically, to the other provider via the TOTSCo Hub. At the same time, SureSwitch sends the required Switching Implications to your customer.

## **Splynx Event Publisher**

The Splynx event publisher updates your Splynx environment when there is a switching event that requires your attention. These events are represented in Splynx as service tickets held against the impacted customer.

When a switch order is received a new ticket is created against the customer with the expected switch date and switching services. When an update is received, the ticket will be automatically updated and if the ticket has been closed it will be reopened.





# **TOTSCo Registration**

All CPs need to be TOTSCo registered by 12th September. CPs can either interact with TOTSCo directly, or via a managed access provider.

## **Full Management MAP**

SureSwitch for Splynx is offered as a 'Fully Managed' solution. This means you'll only need to interact with Zentive, with all TOTSCo processes completed on your behalf.

#### This includes:

- Registering your company with TOTSCo
- Obtaining your RCPID
- Performing integration testing
- Obtaining TOTSCo Ready status
- Paying TOTSCo fees

The TOTSCo fees are charged at the same rate applied if contracting directly with TOTSCo.

# **Pricing**

## **Onboarding Fee**

The SureSwitch onboarding fee is a one-off charge that covers account setup, TOTSCo registration, and required integration to secure TOTSCo Ready status.

## **SureSwitch Subscription & Subscriber Charges**

The SureSwitch software subscription is £100 per month. The Subscriber charge is £0.055 per subscriber per quarter. These charges are invoiced quarterly in advance. We will write to you each quarter to obtain current subscriber numbers.

## **Community Interest Companies**

For Community Interest Companies with up to 500 subscribers we offer a 50% subscription charge discount to £50 per month.

For example, for 500 subscribers the quaterly charge is £150 + £27.50 = £177.50.



#### **TOTSCo Fees**

TOTSCo also bases its fees on a subscription and subscriber basis, however, the fees are invoiced annually up front (Jan - Dec). The subscriber number is the number of customers you had on the 30th of June the previous year.

(The subscriber fees for 2024 are based on the number of customers you had on 30th June 2023)
